New Zealand Deerstalkers Association – Southland Branch 2025 Conference Raffle Terms and Conditions

1. Promoter

This raffle is run by the Southland Branch of the New Zealand Deerstalkers Association (NZDA), a not-for-profit organisation. All proceeds go towards supporting the Southland Branch as hosts of the 2025 NZDA National Conference. The raffle is administered by the NZDA National Office on behalf of the Southland Branch.

2. Raffle Period

Ticket sales will run until 4:00 PM on 19 July 2025, or until all tickets are sold.

3. Draw Details

The prize draw will take place at 4:00 PM on 19 July 2025 and the winning ticket will be announced during the prize giving at the 2025 NZDA National Conference. The winner will also be contacted directly by phone following the draw.

4. Eligibility

Entrants must be 18 years or older and reside in New Zealand. Members of the NZDA and the general public are welcome to enter. NZDA Southland Branch committee members and those involved in the administration of the raffle are not eligible to enter.

5. How to Enter

Tickets may be purchased online or via authorised NZDA Southland representatives. Upon purchase, you will receive an email confirmation listing the number of tickets you hold. Tickets are not individually numbered; the raffle system tracks all entries electronically.

6. Prizes

One winner will receive a prize pack including:
